1. This agreement, entered on ___/___/2021 is made between the Barn Nature Center Foundation and _____ (client).

2. It is hereby agreed that the Barn Nature Center Foundation will provide the following services to the client: ___ **Be a Zookeeper Camp** ___ **Veterinary Assistant Camp**
 - a. Dates: _____
 - b. Time: 9:00am-3:00pm, Monday thru Friday
 - c. Cost: \$300.00 per child
 - d. **Participants must bring their own packed lunch and water bottle.** An afternoon snack will be provided. Campers can refill their water bottles throughout the day.
 - e. Participants should be dropped off and picked up in the All Purpose Room, which is located in the back lower parking lot behind the Barn, unless otherwise instructed.

3. In consideration of selected services outlined above, client agrees to pay the Barn Nature Center Foundation at the rate listed below:
 - a. *\$ 75.00 Non-refundable deposit*
 - b. *\$225.00 Final balance payment*
 - c. **\$300.00 (Total tuition for one week of selected Summer Camp for one child)**

4. Payment will be made in the following manner:
 - a. **Deposit:** a **non-refundable** amount of **\$75.00** due upon registration.
 - b. **Final Payment:** Due **2 weeks** before camp start date.
 - c. **Payment Options:** Payments can be made in cash, Venmo (@Barn-NatureCenter), money order, or check (*made payable to "Barn Nature Center Foundation"*). Deposit can be paid by credit/debit card or PayPal at www.barnnaturecenter.org under the "Summer Camp" tab, click on the "Pay Now" button.

5. Refund Policy:
 - a. Refunds requested prior to 2 weeks before the start of camp will be honored in the amount of the final balance payment (tuition minus deposit). In these cases, the deposit payment may be transferred to another week of camp, but will not be refunded. A \$75 non-refundable deposit applies for each program and each child. There is no fee for switching to another available camp. Barn Nature Center Foundation staff may remove any child from summer camp for inappropriate behavior, in which case no refund will be issued. Barn Nature Center Foundation retains the right to change or cancel any programs as necessary.

- b. In the event that Barn Nature Center Foundation must cancel a summer camp program, tuition will be fully refunded.
 - c. Should the impacts of COVID-19 require your family to cancel summer camp programming less than 2 weeks prior to the program start date, you have the option to receive final balance payment (tuition minus the deposit) credit, in which you may transfer this credit towards a future camp or other program(s).
6. Changes to this contract must be made by the Barn Nature Center Foundation, not the client. The Barn Nature Center Foundation reserves the right to modify and/or change camp program activities and structure based on health, safety, and other variable factors. Requests for changes to selected services are not guaranteed, due to staffing limitations.
